The undersigned is directed by order of the Government to say that the Governor is pleased to approve of the proposal for the establishment of a Degree college at Domjur in the district of Howrah with effect from the academic session 1966-67 subject to the following terms and conditions:-

- i) The organizers shall be required to provide land, by way of a gift or purchase, free from all encumbrances in favour of the College authorities.
- ii) The organizers shall be required to provide, at their own cost; adequate accommodation for conducting classes, office, teachers, detached and essential furniture, equipment, books, etc. for the purpose of the college.


In case of delay in constructing the permanent building the organizers shall be required to construct temporary structure consisting of at least five rooms.


- iii) Estimates of expenditure shall be made for supply of books, printing, stationery and other items for students and members of staff.
- iv) The college shall not be permitted to run higher secondary courses.
- v) The college will be run in the manner provided in the statutes of the affiliating University.
- vi) No special constitution of the Governing Body shall be allowed.
- vii) Terms and conditions for the purpose of affiliation laid down by the University are to be fulfilled.

2. The college may for the present be affiliated in U.A. (Pass) in English, Bengali, History, Education and Geography.

3. The Governor is also pleased to approve of the creation of the following posts in the usual scales of pay with effect from the date of filling up the posts:-


