Programme Outcome and Course Outcome

DEPARTMENT OF ENGLISH:

Programme: B.A. Honours in English and General (Under CBCS)

PROGRAMME OUTCOME (PO):

Programme Outcomes (POs) are the knowledge and skills a graduate is expected to have after completing 3 years of Undergraduate B.A. Programme in English Honours.

The Honours Program in English will help the students to gain knowledge about British Literature and also Literature in English from India and Literature of the world at large through English translations. The students have to study literary texts with reference to the biography of the author and the sociocultural context in which the text was written. The students are encouraged to form their own critical opinions about issues like identity, gender, psychological motivations and inclinations, inter-personal relationships, man and his environment and also archetypal issues across countries and cultures. Students of the Department of English are trained to look beyond the surface of the literary text and gain insights into the characters and the socio-cultural context of the times.

SEMESTER-WISE COURSE OUTCOMES (CO):

Semester 1

CC1 – History of Literature and Philology

CC2 – European Classical Literature

ENGA CC 1: History of Literature and Philology

- CO 1: This course will introduce the students to the history, politics, cultural and social realities
 that influence British literary texts. After completing this course, students will be able to identify
 the major literary trends in Great Britain and contextualize the British writers, like Chaucer,
 Shakespeare, Dryden, Pope, Wordsworth, Coleridge, Dickens, Hardy, Eliot, Joyce, and their works
 in chronological order.
- CO 2: The section on Philology will help students to understand the structural changes in the English language from the earliest times to the present day. The students will gain knowledge about the Scandinavian, French, Latin and American influences on the English language and learn to identify the etymology of words they use in daily conversation.

ENGA CC2: European Classical Literature

- CO 1: In this course, the students will study English translations of European classical texts, like translations of the Greek works of Homer and Sophocles and the Latin works of Ovid, Plautus and Horace. The students will become familiar with primary literary texts and understand the culture of the classical times. They will understand how ancient European classics have influenced British Literature, for example, Ovid's *Metamorphosis* has been used by generations of writers, from Shakespeare in the 16th century to Kafka in the 20th century.
- CO 2: Students will be able to trace the development of literary genres, the epic, tragedy, comedy and satire from the classical translations. Sophocles' *Oedipus Rex* will teach them the principles of Greek Tragedy as laid down by Aristotle, while Plautus' *Pot of Gold* will give insight into Roman society and show the influence of Greek New Comedy on later English comedies.

Semester 2

CC3 – Indian Writing in English

CC4 – British Poetry and Drama (14th – 17th century)

ENGA CC 3: Indian Writing in English

• CO 1: Students will be introduced to Indian writing in English in this course. Bankim Chandra's *Rajmohan's Wife*, the first English novel by an Indian, will give them insight into the contemporary society of the late 19th century rural Bengal. Mahesh Dattani's *Bravely Fought the Queen* will help them understand the life and times of 20th century urban India. The poems of early Indian poets, as Derozio, Toru Dutt and Sarojini Naidu, and modern poets as Nissim Ezekiel, Ramanujan, Kamala Das will make students aware of the evolving tradition of Indian poetry in English.

ENGA CC 4: British Poetry and Drama (14th - 17th century)

- CO 1: The students will become familiar with the English Sonnet and the great Renaissance Sonneteers Sidney, Spenser and Shakespeare. The Metaphysical poetry of Donne and Marlowe which revolutionized poetry by the assimilation of diverse experiences through complex images and conceits will familiarize students with the variety of poetic forms.
- CO 2: Shakespeare's tragedies and comedies in this course will introduce students to a unique literary space where emotional depth blends with intellectual perceptions generating profound philosophy and aesthetic sublimation.

Semester 3

CC5 – American Literature

CC6 – Popular Literature

CC7 – British Poetry and Drama (17th – 18th century)

ENGA CC 5: American Literature

- CO 1: This paper will familiarize students with American literary, cultural and political history through prose, poetry, drama and novel by writers like Whitman, Miller, Faulkner, Fitzgerald, Poe, Hemingway and literary feminist icons like Sylvia Plath.
- CO 2: The students' will understand the American way of life, especially the influence of race, class and gender in American society. They will realize how the "American Dream" and the Great Depression have influenced American society as social issues and political movements, as racism, black slavery, Civil War, are manifest in American literature.

ENGA CC 6: Popular Literature

• CO 1: This course consists of popular literature from South Asia and American and European popular culture. A comic book like Herge's *Tintin in Tibet* is taught in this course along with Sukumar Ray's *Abol Tabol* and novels of Lewis Carroll and Agatha Christie. The students will come to know the theories of children's literature, especially the 'sense behind nonsense' that will give them a new insight into popular literature.

ENGA CC 7: British Poetry and Drama (17th-18th Century)

- CO 1: This course will introduce the students to classics like John Milton's *Paradise Lost* and Alexander Pope's *The Rape of the Lock*. John Webster's *The Duchess of Malfi* and Aphra Behn's *The Rover* will help them understand the later phases of Renaissance, especially the decadence, and the growing trend of 'Literature of Satire' in the 18th century.
- CO 2: The students will realize how political and social conditions in different periods of British history have given rise to particular literary genres. The work of Aphra Behn, one of the first English women to earn her living by her writing, will give insight into the problems faced by women in Restoration England and the challenges faced by woman writers. Behn broke cultural barriers and became a role model for later generations of women writers.

SEC A2: Business Communication

• CO 1: This is a skill enhancement course aimed at teaching students the skills required to write reports, letters, e-mails, curriculum vitae and minutes of meetings. This paper is important for developing skills for future employment.

Semester 4 CC8 –British Literature (18th Century) CC9 –British Romantic Literature CC10 –19th Century British Literature

ENGA CC 8: 18th century British Literature

• CO 1: This course will familiarize students with print culture and its influence on literature in the 18th century. The works of Samuel Johnson, Joseph Addison and Daniel Defoe will introduce students to 'periodicals' that gained immense popularity during this period.

ENGA CC 9: Romantic Literature

• CO 1: The Rise of Romanticism had a profound influence in Europe as it challenged the conventional beliefs and proposed new ideas of the self, natural world, freedom of man and the role of the artist. The philosophical ideals of Romanticism expressed in the works of Blake, Wordsworth and Coleridge and the other Romantic poets will help students realize the great changes taking place in English literary tradition and contemporary English life. The Romantic science-fiction by Mary Shelley (*Frankenstein*) and non-fiction by Charles Lamb (*Essays of Elia*) will provide a wide-ranging understanding of the age through diverse literary genres.

ENGA CC 10: 19th century British Literature

- CO 1: The students will understand the great socio-economic cultural changes that took place in 19th century Britain such as, industrial revolution, capitalism and urbanization of England, decline of Christian belief, emancipation of women and the expansion of the British Empire. This course will introduce students to these changes through literary texts which reflect social transformation.
- CO 2: The students will be introduced to the English Novel, the dominant literary genre of this period, through the novels of Jane Austen and Charles Dickens. They will understand how novels portray the life of the times. The dramatic monologues of Tennyson, Browning and Arnold will develop students' analytical skills by reading poems with deep socio-cultural and psychological underpinnings.

SECB2: Academic Writing and Composition

• CO 1: This is a skill enhancement course aimed at developing students' skills of analysis based on reading poems and prose passages. It encourages research skills by making students apply citation to sources. This course is important for developing skills for future researchers.

Semester 5

CC11 - Women's Writing

CC12 – Early 20th Century British Literature

ENGA DSE A-1: Indian Literature in Translation

ENGA DSE B-1: Literary Types

ENGA CC 11: Women's Writing

• CO 1: This course includes women's writings like iconic feminist texts like Mary Wollstonecraft's *A Vindication of the Rights of Woman* and poems, novels, short stories and the first autobiography by an Indian woman, Rassundari Devi's *Amar Jiban*. Among other texts, there are poems of Emily Dickinson, Elizabeth Barrett Browning and Eunice de Souza, Alice Walker's novel *Color Purple*, and short stories, like Mahasweta Devi's *Draupadi* and Katherine Mansfield's *Bliss*. This course portrays women's lives in a patriarchal society and aims at gender sensitization.

ENGA CC 12: Modern British Literature

• CO 1: Modernism in British Literature is taught in this course through poems of T. S. Eliot, W. B. Yeats and Wilfred Owen that portray the paradigm shift in Britain after the two World Wars. The psychological aspect of modern literature is explored in the novels of Joseph Conrad and D. H. Lawrence. G.B. Shaw's problem play, *Pygmalion*, introduces students to the social realities of the changing times.

ENGA DSE A-1: Indian Literature in Translation

• CO 1: This course teaches contemporary Indian literature written in various Indian languages, like Hindi, Bengali, Odia, Panjabi and Urdu, through English translation. The students understand the diversity of Indian culture and the importance of translation or English as a link-language in a linguistically diverse country like India. English translations enable students to read the works of Ismat Chughtai, Fakir Mohan Senapati, Munshi Premchand, Vijay Tendulkar, G. M. Muktibodh and Amrita Pritam.

ENGA DSE B-1: Literary Types

CO 1: This course will familiarize students with the genres of tragedy, comedy and the short story.
 Apart from this, they will be able to identify and use rhetorical devices in English language and prosody in poetry. A major outcome of this course is the development of scansion skills of the students.

Semester 6 CC13 – Modern European Drama CC14 – Postcolonial Literature

ENGA CC 13: Modern European Drama

• CO 1: The plays by Henrik Ibsen, Bertolt Brecht and Samuel Beckett in this course will help students to understand the changes in 20th century European drama and its influence on British Drama. The plays were controversial in their times as the playwrights used their work to resist and subvert conventional ideas prevailing in society and conventional dramatic principles. Through these plays the students will know about social realities and innovative dramatic art that reflect the modern times. They will be introduced to thought provoking concepts like absurdism, alienation and dramatic genres as theatre of the absurd and epic theatre.

ENG A CC 14: Postcolonial Literature

- CO 1: In this course, the students will read English Literature from former colonies of the Britain, like India, Australia and Latin America. They will understand the dominant concerns of postcolonial literature and their historical, cultural and theoretical contexts.
- CO 2: After completing this course, the students will be able to critically evaluate postcolonial texts without the assumptions and prejudices of racism inherent in any colonial situation. This paper is significant for Indian students as India is a postcolonial nation.

ENGA DSE A-3: Partition Literature

- CO 1: Partition Literature is a significant part of Indian literature and the students will realize the trauma of Partition through the works of writers who portray the traumatic times in post-independence India. The stories of Prativa Basu and Manik Bandopadhyay; poems by Birendra Chattopadhyay and Sankho Ghosh and Amitava Ghosh's novel, *The Shadow Lines* reflect the chaotic times in Bengal. The identity crisis after Partition in Punjab is portrayed in Sadat Hasan Manto's *Toba Tek Singh*. Sahir Ludhianvi's *Twenty-sixth January* is relevant even today as he holds the leaders responsible for the dismal state of the country.
- CO 2: This course will help the students to understand the problems of modern India by tracing
 them to their origins in the Partition of the country. They will be able to empathize with an earlier
 generation of Indians who desperately struggled to rebuild their lives in an alien land they were
 forced to accept as their new homeland.

DSE B-3: Autobiography

- CO 1: This course will introduce students to the literary genre of 'Autobiography' through the works of Rabindranath Tagore, Binodini Dasi, Mahatma Gandhi and Nirad Chaudhuri. Students will be able to distinguish subjectivity and objectivity in literature as the personal predilections of the author usually influence and shape his / her perception of reality.
 - CO 2: The English Department encourages the students to contextualize the autobiographies and study the texts as pictures of contemporary society. The socio-cultural contexts will help the students to critically analyze the autobiography for its historical value. This course will also introduce the students to Memory Studies as memory plays a significant role in the scripting of an autobiography.

BNG-A-CC-1-1-TH-TU
