This Memorandum of Understanding (MoU) is a framework for specific collaborative initiatives to be developed and signed between two institutions, **on 10.03.2023** in collaborative and mutual programmes that will enhance the intellectual life of both the institutions, contribute to increased cooperation and promote mutual understanding. Thus, **Panchla Mahavidyalaya**, Raghudevpur, Rajapur, Uluberia, Howrah, PIN -711322. And **Azad Hind Fouz Smriti Mahavidyalaya**, J6GM+462, Amta Road, Baruipara, Domjur Howrah., Pin 711405, have agreed to the following:

Areas of Collaboration

Both the parties have agreed to explore and implement mutually rewarding initiative in the following areas of academic cooperation

- Online sharing of Teaching-Learning and e-Governance.
- Collaborative Research
- Faculty and student mobility
- Library sharing
- Arranging collaborative seminars and workshops.
- Other academic collaborations including publications.

Development of initiatives.

Areas of collaboration will be defined between the Panchla Mahavidyalaya and Azad Hind Fouz Smriti Mahavidyalaya throughout the duration of the MoU and further advancement of Academic collaboration may result for specific collaborative activities.

Neither institution will have any financial commitments to each other, nor through this MoU, real or implied. Both the parties agree, however to endeavour to secure government, corporate or other party funding where possible in order to support the collaborative activities covered by the agreement.

Confidentiality and Intellectual Property Rights (IPR) protection

Both the institutions shall respect and retain confidentiality in each/ any of the collaborative efforts, and all collaborative academic exercises shall be guided, directed and impelled by the greater academic interest of both the colleges, and not any other/ commercial interest.


This MoU will respect Intellectual Property Rights and any intellectual matter developed by the collaborative efforts of two institutions shall be retained by them.

Duration, Amendment and Termination of the MoU

This MoU will remain in effect for a period of 5 (Five) years from the last date of signing. It may be amended at any time by mutual agreement and in writing as an addendum. No legal relationship between the two institutions is implied through this agreement. Either party may terminate this MoU at any time and for any reason by giving the other party at least three (3) months written notice of its decision.


