MODE OF OPERATION

This MoU shall be effective from the date it is signed by both the parties, viz. 16.01.2023.

Both parties will provide necessary support for effective implementation of the MoU within the framework of institutional rules, regulations and procedures.

The activities under this MoU shall be coordinated, monitored and recorded by the Internal Quality Assurance Cell (IQAC) of Azad Hind Fouz Smriti Mahavidyalaya and Purbasha Eco Helpline Society.

No financial commitment is required / involved to execute the terms and conditions of the MoU.


Any financial commitment for joint activities under this MoU shall be subject to the approval of the competent authorities of the respective organizations.



Terms and conditions:

It is mutually understood and agreed by Azad Hind Fouz Smriti Mahavidyalaya and Purbasha Eco Helpline Society, that:

1. Azad Hind Fouz Smriti Mahavidyalaya and Purbasha Eco Helpline Society may collaborate in various environment related activities and may seek funding from Government and private agencies of National and / or International repute.
2. Azad Hind Fouz Smriti Mahavidyalaya and Purbasha Eco Helpline Society may mutually use and share educational resources and may jointly guide students at various levels of academia and environmental protection activities.
3. Azad Hind Fouz Smriti Mahavidyalaya and Purbasha Eco Helpline Society may mutually conduct professional course/ training programmes/ workshops / seminars/ conferences/ field study for which certificates will be jointly issued by Azad Hind Fouz Smriti Mahavidyalaya and Purbasha Eco Helpline Society to all candidates after successful completion of the same.
4. This MoU shall be governed and construed according to the laws of the country for each participating party. In case of any dispute resulting from or related to this MoU, both parties will try to resolve such disputes amicably. Any dispute will be jointly resolved by involving the Principal of Azad Hind Fouz Smriti Mahavidyalaya and the President of Purbasha Eco Helpline Society in a spirit of independence, mutual respect and shared responsibility.
