Further continuance of your research work will depend on satisfactory result at the test. In the event of unsatisfactory result, the appropriate authority of the University may allow you to appear at a second test within six months of such decision, but not before six months from the date of the first test. If the result of the second test is also found not to be satisfactory, the registration may be cancelled.
