I am to inform you that the Research Advisory Committee in Commerce (subject) of Sidho-Kanho-Birsha University at its meeting held on 14.06.21 recommended your name for registration as a candidate for the Ph.D. Programme of this University for the research works under the title

subject to fulfillment of the requirements set forth in the Ph. D. Regulations of the University relating to the Ph.D. Degree and such other terms and conditions as may be laid down by the UGC and other appropriate authorities of the University from time to time.

You will now be required to deposit the Ph.D. Registration fee of Rs 10000/- (Rupees Ten Thousand) for the Ph.D. Degree, positively within a month from the date of issue of this letter, failing which your case will not be considered for Registration as a Ph.D. Candidate.

In this connection you are requested to note that -


- You will be required to get yourself registered as a student of this university on migration after completing all the necessary formalities prescribed in this behalf, unless you are already a registered student of this University.
- You have been permitted to do research work under the guidance of Prof./Dr. Pradipta Banerjee as your Supervisor(s).
- Under Ph.D. Regulations, 2016 of UGC and also as per Ph. D. Regulations of this University, prior to submission of the thesis, you will be required to make two presentations on your Ph.D. work in seminars before the members of the Research Advisory Committee of the concerned Department including the Supervisor and the Co-Supervisor (if any). The necessary evidence of publication of at least two research papers related to your research work in refereed journal must have to be produced at the time of submission of your thesis.

- (d) After successful delivery of two seminar presentations before the concerned RAC, you will be required to apply to the Registrar together with the Supervisor's Certificate for granting you the permission for submission of the thesis. You will submit your thesis for adjudication within a period of six months from the date of pre-submission (i.e. the second and final) seminar presentation.
- (e) You will have to submit your thesis with the office of the Registrar within six years from date of your enrolment / admission to Ph.D. Programme mentioned above, but not earlier than three years i.e. 19/03/23 in the prescribed manner along with the fee of Rs 15000/- plus necessary postage /or a fee as may be fixed by the Executive Council from time to time towards submission of thesis.
- (f) For carrying out your research work, you will be required to get yourself in touch with your Supervisor and Co-Supervisors (if any) on continuous basis and you will be required to produce a certificate from the Supervisor about your satisfactory progress in your research work from time to time.
- (g) All the requisite fees should be deposited at the University in cash or through online mode of payment indicated by the University and the relevant evidence for such payment should be preserved. This payment evidence may have to be submitted to the Ph.D. unit of the Registrar's Department, if required.
- (h) In your case, five /six copies of the thesis (computer typed in MS Words) in bound form along with electronic version of the thesis in PDF format are to be submitted.
- (i) At the time of submission of thesis, a certificate in prescribed form furnished by your Supervisor and from the Co-Supervisor will have to be attached to all the copies of the thesis. Such certificate shall mention the genuineness and originality of the Research Work. You will also be required to submit six copies of Synopsis/abstract of the thesis (normally in not more than five thousand words) along with the thesis. While the thesis is submitted in regional language for language subjects, the synopsis of the thesis is also to be translated in English language.
- (j) At the time of submission of the thesis you will have to produce a certificate from the HOD of the concerned Department regarding presentation of two seminar lectures before the RAC and the Clearance Certificate from the Librarian of the University and from the respective Department.
- (k) At the time of submission of the thesis for adjudication for award of the Ph.D. Degree, you shall have to submit an undertaking indicating that the thesis has been prepared by you and the thesis is your original work and it is free of any plagiarism. You shall also submit a certificate from your supervisor indicating that the research work done by the researcher under his/her supervision is plagiarism free.
- (l) The registration granted under this letter will remain valid for Six years from the effective date of registration. In the event of failure of submission of the thesis within the stipulated period, re-registration may be sought for and the same may be granted after fulfilling all the required conditions in this behalf and on receipt of prescribed fee.
- (m) The registration granted herein may be cancelled by the concerned authority/body of the University in the event of failure of the candidate to fulfill any of prescribed requirements at any stage.
- (n) Progress of Research Work, Attendance and Good Conduct Reports from the Supervisor and Co- Supervisor (if any) in respect of the candidate should be submitted at regular intervals.


